8. Program/Project Update

Director of Engineering Michael Bessette gave a presentation outlining the recent and ongoing activities. He reported the design team has been aggressively advancing the design to replace the existing slurry wall in Reaches 14-16. He reported the 90 percent designs were completed and delivered on July 7 for review by SBFCA, USACE, DWR and the IPE.

Executive Director Mike Inamine gave a presentation outlining the issues the Agency has been addressing through the regulatory agencies. He described SBFCA staff attempts to acquire funding and authority for repair through the federal PL84-99 program, Operations & Maintenance Repair, Replacement and Rehabilitation (OMRR&R) and

Section 408 authorization. He reported that negotiations are ongoing with the Corps of Engineers and DWR on authorization and funding.

Director Jim Whiteaker inquired if we can work simultaneously under both options.

Mr. Inamine answered that we can and are working on these approaches concurrently.

Mr. Inamine reported that a public outreach meeting is scheduled for 6:30 on July 12, 2017 at Veteran's Memorial Hall (Tucker Room), 1425 Veteran's Memorial Circle in Yuba City for the residents on Second Street who may be impacted during construction.
